The JBL Fest 2018 Sweepstakes ("Sweepstakes") is sponsored by Harman International Industries, Inc. ("Sponsor"), 400 Atlantic Street, Stamford, CT 06901, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI USA 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on August 16, 2018 and ends on September 17, 2018 ("Sweepstakes Period"). The Sweepstakes is only open between 4:00 PM Eastern Time ("ET") and 5:00 PM ET each day during the Sweepstakes Period. The Sweepstakes consists of a grand prize drawing ("Grand Prize Drawing") and thirty-three (33) daily entry periods (each a "Daily Entry Period") as outlined in the chart below:

Non-winning entries will not carry over into subsequent Daily Entry Period drawings. Administrator’s computer is the official Sweepstakes clock.

- 2. ELIGIBILITY:** This Sweepstakes is offered to legal residents of the fifty (50) United States and the District of Columbia who are twenty-one (21) years of age or older at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, , and each of their respective parent companies, subsidiaries, affiliates, officers, governors, owners, distributors, retailers, advertising/promotion agencies, and companies involved in the implementation and execution of the Sweepstakes (collectively “Sweepstakes Entities”) and each of their respective immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Void where prohibited or restricted by law. All applicable federal, state, and local laws and regulations apply.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winner may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

- 3. HOW TO ENTER:** During the Sweepstakes Period, an eligible entrant may visit www.jblfest.com (“Website”) and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials) and valid e-mail address and will be prompted to select an avatar. Entrant may register any time during the Sweepstakes Period. During each Daily Entry Period, an eligible entrant may return to the Website and upon the successful submission of the registration information or log-in (if entrant is returning to the Website), an entrant will receive one (1) entry into the applicable Daily Entry Period and one (1) entry into the Grand Prize Drawing. Entrants must register or log-in during the one (1) hour Daily Entry Period in order to earn a Daily Entry Period Sweepstakes entry and a Grand Prize Drawing Sweepstakes entry.

An entrant will receive no more than one (1) Daily Entry Period entry and one (1) Grand Prize Drawing entry per day. If more than the stated number of entries are received from the same person, and/or e-mail address, the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may not be eligible to win a prize.

RANDOM DRAWINGS: On or about each day outlined in the chart above in Section 1, the Administrator will randomly select one (1) potential Daily Entry Period winner from all eligible entries received during the respective Daily Entry Period. On or about September 18, 2018, the Administrator will randomly select five (5) potential grand prize winners from among all eligible entries received during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), ODDS OF WINNING:

A. Grand Prizes (5): The grand prize is a trip for two (2) to Las Vegas, Nevada for JBL Fest ("Grand Prize"). Trip includes round-trip, coach class air transportation for two (2) people (for winner and one [1] guest) from a major commercial airport near the winner's residence (as determined by Sponsor) to Las Vegas, Nevada, three (3) nights hotel standard accommodations (single room/double occupancy), breakfast daily at hotel, access for two (2) to the JBL Platinum Party, access for two (2) to a JBL Live! Performance, access for two (2) to JBL Sound Splash, ground transportation to/from hotel and airport, group transportation to all JBL FEST events, food and non-alcoholic beverages at all JBL FEST events, and a monorail pass for winner and guest. Winner's guests must be twenty-one (21) years of age or older at the time of signing travel liability release. If the winner elects to travel or partake in the Grand Prize without a guest, no additional compensation will be awarded to the winner. Winner must travel on October 17, 2018 and return on October 20, 2018 or Grand Prize will be forfeited. Winner and guest must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the prize will not be awarded. If winner resides within a 100-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having valid travel documents including government identification and/or passports. Should any event, element or detail of the Grand Prize become unavailable, the Sponsor shall have no obligation to the winner aside from providing the remaining

portion of the Grand Prize, minus any unavailable event, element or detail. Only Five (5) Grand Prizes are available in the Sweepstakes. The ARV of each Grand Prize is \$3,762 and the ARV of all five (5) Grand Prizes is \$18,810. Any difference between the estimated ARV and the actual value of the prize will not be awarded. The Grand Prize winner will not be eligible to also win the Grand Prize in the “JBL Fest 2018 Retailer Sweepstakes”.

Thirty-three (33 Daily Prizes (one [1] per Daily Entry Period) will be available in the Sweepstakes. The ARV of all Daily Prizes is \$3,284.70.

C. Total ARV of All Prizes: The total ARV of all prizes in the Sweepstakes is: \$22,094.70.

D. Odds of Winning: The odds of winning a Grand Prize depend on the total number of eligible entries received during the Sweepstakes Period. The odds of winning a Daily Prize depend on the total number of eligible entries received during each respective Daily Entry Period.

E. General: In no event will more than five (5) Grand Prizes and thirty-three (33) Daily Prizes (one [1] per Daily Entry Period) be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the prizes through a random drawing from among all eligible prize claims received. No prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure. Limit: One (1) Grand Prize and one (1) Daily Prize per person.

6. HOW TO CLAIM A PRIZE: After the random drawings, Administrator will notify the potential winners via e-mail at the e-mail addresses provided at the time of registration. Each potential Grand Prize winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within three (3) calendar days from the date of attempted notification or the Grand Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Potential Grand Prize winners may also be required to provide a social security number. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim a prize, and may result in the prize being awarded to an alternate winner, if time permits. Upon verification of eligibility, Daily Prizes will be mailed to the winners at the physical addresses (P.O. Boxes are not permitted) provided at the time of entry and the winner will be contacted to arrange fulfillment of the Grand Prize. The Sweepstakes Entities shall not be held responsible for any delays in awarding a prize for any reason. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept a prize, or if a winner notification is returned as undeliverable or a potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, the respective prize may be forfeited. ARV is as of the time these Official Rules were printed and the value of the prizes may fluctuate. The winners are not entitled to any difference between the ARV and the actual value of a prize at the time the prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Each prize will only be awarded to a verified winner.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail notifications, telephone calls, or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/Internet/website/UseNet accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property (including any injury related to dancing or creating the entry), to entrants or to any person's computer or any electronic device related to or resulting from participating in the Sweepstakes and/or accepting or using a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. If Sponsor, in its discretion, elects to alter this Sweepstakes as a result of a Force Majeure event, a notice will be posted at the Website.

DISPUTES:** This Sweepstakes is governed by, and will be construed in accordance with, the laws of the state of Michigan, and the forum and venue for any dispute shall be in Oakland County, Michigan. If the controversy or claim is not otherwise resolved through direct discussions or mediation, it shall then be resolved by final and binding arbitration administered by JAMS in accordance with its arbitration rules and procedures or subsequent versions thereof ("JAMS Rules"). The JAMS Rules for selection of an arbitrator shall be followed, except that the arbitrator shall be experienced and licensed to practice law in Michigan. All proceedings brought pursuant to this paragraph will be conducted in Oakland County, Michigan. The remedy for any claim shall be limited to actual damages, and in no event shall any party be entitled to recover punitive, exemplary, consequential or incidental damages or have damages multiplied or otherwise increased, including attorneys' fees or other such related costs of bringing a claim, or to rescind this agreement or seek injunctive or any other equitable relief. Entrants agree that the rights and obligations of any entrant and/or Sweepstakes entities and/or any other party shall be resolved individually, without resort to any form of class action. Any demand for arbitration must be filed within one (1) year of the time the cause of action occurred, or the cause of action shall be forever barred.
